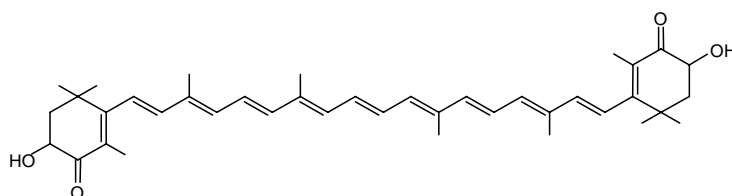

Dispersibility

CAROPHYLL[®] Pink 10% CWS is dispersible in cold water, yielding a red coloration.

Preparation of solutions: slowly add the powder to 10–15 times its weight in cold or warm water under continuous stirring.

CAROPHYLL[®] Pink 10% CWS is sensitive to air, heat, light and humidity. The product may be stored for 36 months from the date of manufacture in the unopened original container and at a temperature below 15 °C. The 'best use before' date is printed on the label. Keep container tightly closed. Once opened, use contents quickly.
